What data do we collect?

GMT collects the following data:

- Personal user identification information;
- Personal claim related information;
- · Commercial claim related information;

How do we collect your data?

You directly provide GMT with most of the data we collect. We collect data and process data when you:

- Register online or use our online services.
- Voluntarily complete a questionnaire, customer survey or provide feedback on any of our services or via email.

GMT may also receive your data indirectly from the following sources:

- Third-party agencies.
- Marketing agencies.
- Defendants.

How will we use your data?

GMT collects your data to:

- Process and manage your claim.
- Email and SMS communications to collect additional claim information.
- Email and SMS communications to provide case updates.

GMT may share restricted elements of your data, as legally and operationally required, with our partner companies, defendants and relevant courts.

When GMT processes your registration, it may send your data to, and also use the resulting information from, credit reference agencies and data registries to prevent fraud.



How do we store your data?

GMT securely stores your data at our secure global data centers. Where and as appropriate we have appointed represented in different jurisdictions.

GMT will keep your personal and claim data for a minimum of 6 years. Once this time period has expired, we will delete your data.

Marketing

You cannot opt out of receiving case communications by email and/or SMS messages which are sent by GMT to enable the lawyers acting in the case to represent you in the case and manage your claim because electronic communication is crucial to the management of the case.

GMT will send you information about the claims you have expressed an interest in joining.

If you have agreed to receive marketing, you may always opt out at a later date.

You have the right at any time to stop GMT from contacting you for marketing purposes or giving your data to other members of the GMT Group.

If you no longer wish to be contacted for marketing purposes you can unsubscribe via the unsubscribe hyperlink located in the footer of the email.

What are your data protection rights?

GMT would like to make sure you are fully aware of all of your data protection rights. Every user is entitled to the following:

The right to access - You have the right to request GMT for copies of your personal data. We may charge you a small fee for this service.

The right to rectification - You have the right to request that GMT correct any information you believe is inaccurate. You also have the right to request GMT to complete information you believe is incomplete.

The right to erasure - You have the right to request that GMT erase your personal data, under certain conditions. Unless your participation in the group action is terminated by you exercising your right to cancel in the 14 days cooling off period you cannot thereafter, unless agreed as provided for in the documentation agreed by you when joining the group action, request that your information be erased.

The right to restrict processing - You have the right to request that GMT restrict the processing of your personal data, under certain conditions. Unless your participation in the group action is terminated by you exercising your right to cancel in the 14 days cooling off period you cannot thereafter, unless agreed as provided for in the documentation agreed by you when joining the group action, request that the processing of your information be restricted.

The right to object to processing - You have the right to object to GMT's processing of your personal data, under certain conditions. Unless your participation in the group action is terminated by you exercising your right to cancel in the 14 days cooling off period you cannot thereafter, unless agreed as provided for in the documentation agreed by you when joining the group action, object to the processing of your information.

The right to data portability - You have the right to request that GMT transfer the data that we have collected to another organization, or directly to you, under certain conditions. You may not request that GMT transfer the data that we have collected to the Defendant in the case.
